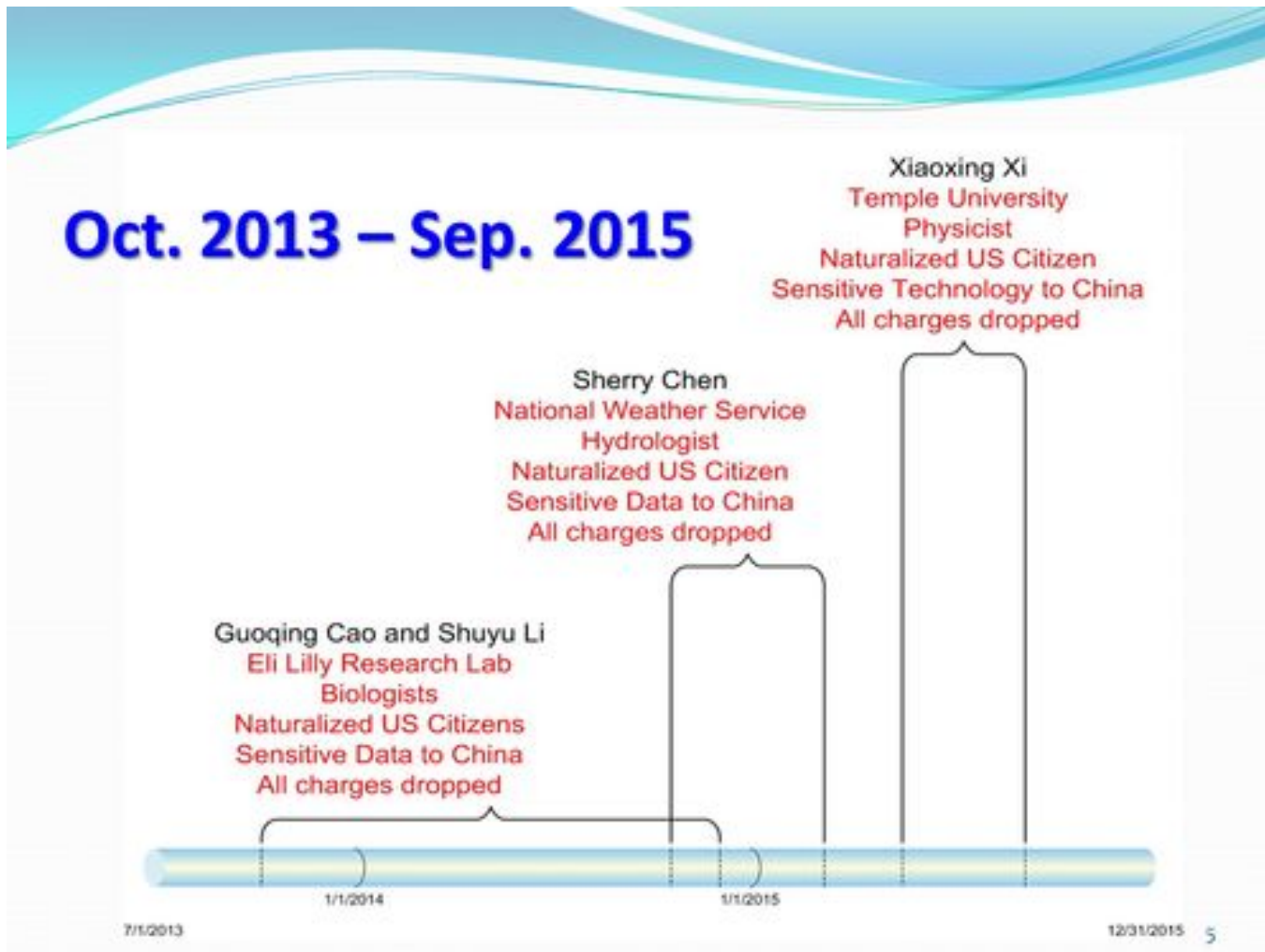

The Legal Referral Service Process

法律转介服务流程

- An intake process where a staff member, under the direction of Advancing Justice | AAJC attorneys, will ask you a few questions about your situation.

- Provide you with appropriate legal referrals

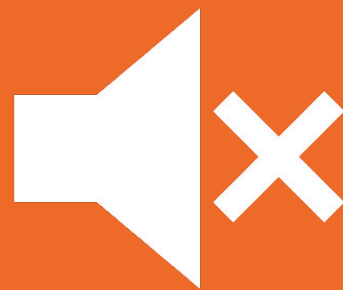

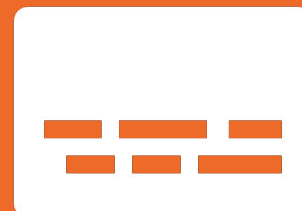
