It will explore how the Justice Department's current actions conflict with existing national policies to promote and protect fundamental scientific research. The government's over-zealous and xenophobic targeting of Asian American and Asian immigrant scientists particularly drive needed scientific talents away from our nation. Speakers will discuss how this racial targeting not only undermines the rights and welfare of many Americans, but also detrimentally impacts American research and enterprise. Our expert panel will discuss constructive policy ideas and changes to ensure U.S. research security and to protect the future of American science and innovation.

Due to the coronavirus pandemic, collection of 2019 data for The Employer Information Report EEO-1, one of the key efforts of OEDA, was delayed. The EEO-1 Report is a compliance survey mandated by federal statute and regulations. The survey requires company employment data to be categorized by race/ethnicity, gender and job category.
