The next APA Justice meeting will be held on May 3, 2021. Tentative agenda for the meeting will cover the newly appointed AAPI Senior AAPI Liaison at the White House, the May 15 nationwide "Unity Against Hate" rally, The Yellow Whistle Campaign, an impacted professor from the New York University School of Medicine, and updates from the Anti-Racial Profiling Project, requested House hearing, and the Congressional Asian Pacific American Caucus. ### Breaking Bloomberg Report and "China Initiative"

On April 26, 2021, Bloomberg published "[Anti-Asian Atmosphere Chills Chinese Scientists Working in the U.S.](#)" According to the report, Dr. Nianshuang Wang arrived from China in the U.S. seven years ago. His work enabled Moderna Inc. to develop its Covid-19 vaccine in record time. He and his wife are now confronting another kind of contagion. Growing anti-Chinese sentiment is palpable, making him and other Chinese scientists increasingly afraid that they're no longer welcome in the U.S. An explosion of hate attacks against Asian Americans in the past year has been blamed on the xenophobic rhetoric of former President Trump, particularly his racist broadsides labeling the novel coronavirus the "Chinese virus" and "kung flu." But other U.S. leaders and institutions have helped inflame the situation, arousing particular suspicion toward people of Chinese descent. On April 20, 2021, Lisa Monaco, was confirmed by the Senate as the Deputy Attorney

General, the No. 2 role at the Justice Department (DOJ). She was formerly the director of the National Security Division at DOJ. On April 21, 2021, Vanita Gupta, was confirmed as the Associate Attorney General, the No. 3 role at DOJ. She was previously head of the Leadership Conference on Civil and Human Rights and former director of the Civil Rights Division at DOJ. Merrick Garland was confirmed to be Attorney General on March 10, 2021.

The trial of University of Tennessee Professor Anming Hu is set to begin on May 25, 2021 after the government withdrew its motion to continue. Read more at: [https://bit.ly/APAJ\\_AnmingHu](https://bit.ly/APAJ_AnmingHu)

The U.S. District Court in Houston will hold a hearing on the motion to revoke or rescind the detention order for Texas A&M University professor Zhendong Cheng on May 6, 2021, starting at 1:30 pm CT. Professor Cheng has been denied bail since his arrest in August 2020 and has contracted Covid-19 while in detention. The charges against Professor Cheng do not involve economic espionage or trade secret theft despite the rhetoric under the "China Initiative." Read more about the hearing at <https://bit.ly/3njls3g>

On April 21, 2021, [DOJ announced the indictment](#) of Mathematics Professor Mingqing Xiao of at Southern Illinois University – Carbondale with two counts of wire fraud and one count of making a false statement under the "China Initiative."

## **Protecting Science and Exaggerated Threat**

On April 9, 2021, leaders of the House Committee on Science, Space, and Technology and the House Committee on Armed Services sent a joint letter to President Biden, calling for a measured and balanced approach to strengthen the security and integrity of the country's academic research enterprise in facing the reported risks posed by undue foreign influence. The suggestions include:

- Transparency about the nature, scale, and scope of the risks.
- Coordination and clarity regarding research security and integrity requirements.
- Commitment to openness and collaboration.
- Strong investment in United States research and development.
- Trusting partnership between the federal government and the academic community.

## Laws and Rallies Against Anti-Asian Hate

On April 22, the U.S. [Senate passed](#) the [COVID-19 Hate Crimes Act \(S.937\)](#), which hopes to address the large increase in anti-Asian hate crimes. The measure passed 94-1. The bill requires a designated officer or employee of the Department of Justice (DOJ) to facilitate the expedited review of COVID-19 hate crimes and reports of COVID-19 hate crimes. It defines COVID-19 hate crime as a violent crime that is motivated by two things: (1) the actual or perceived characteristic (e.g., race or ethnicity) of any person, and (2) the actual or perceived relationship to the spread of COVID-19 of any person because of that characteristic. The bill requires DOJ to issue guidance for state and local law enforcement agencies on how to establish online hate crime reporting processes in multiple languages and how to expand culturally competent education campaigns. Additionally, DOJ and the Department of Health and Human Services must issue guidance on best practices for mitigating racially discriminatory language in describing the COVID-19 pandemic. A companion bill ([HR.1843](#)) introduced by Rep. Grace Meng is pending in the House.

On April 15, 2021, [NBC News reported](#) on the documentary "The Six" which highlights Chinese survivors from the Titanic. "The horrendous events that we saw in Atlanta really just highlight that the issues that six Chinese passengers on the Titanic faced over 100 years ago are still issues in the United States today," the film's lead researcher said.
